- Personnel available 24 hours a day, 365 days a year to respond to initial calls. Arrangement Conference.
- Clerical assistance in the completion of various forms and permits associated with the funeral.
- Also covers overhead, including facility maintenance, equipment and inventory costs, insurance and administration.
- Expenses, and governmental compliance.

#### Transfer | \$325.00

Transfer of deceased from the place of death to funeral home (within a 30-mile radius, one way).

- Additional Staff for over 250 Pounds | \$65.00 Additional

## Refrigeration | \$75.00 (Daily)

Every licensed funeral director who holds an un-embalmed body for a period longer than 24 hours shall cause the body to be refrigerated. CA Code of Regulations 1233c

#### Crematory Fee | \$495.00

Includes a non-witness cremation, unscheduled.

## Removal of Battery-Operated Device | \$125.00

Pacemakers or defibrillators must be removed before the cremation process takes place.

#### Cremation Container | \$155.00

Tan interior & exterior, made of fiberboard. Required for a cremation.

#### Plastic Urn | \$25.00

Durable plastic urn.
